Public Forum Info.

On November 2nd, you will be asked to vote on several important issues. One very important issue is a 2.5 mil property tax increase for public safety.

Bridgeport Township has historically been able to fund our police and fire department, parks and recreation department, and other services solely from the General Fund. However, with significant cuts to State Revenue Sharing and decreases in property tax revenue, the Township General Fund can no longer fully fund all services.

The Township has made significant cuts to all departments and has reduced staffing levels where feasible. Expenditures are scrutinized by the Manager and must be justified by the requesting department. We also continue to seek out revenue opportunities to offset these lost revenues.

As difficult an issue as this is, it is time for the citizens of Bridgeport to decide the level of services they wish the Township to provide and maintain. The Township Board of Trustees is placing this question before our voters on November 2nd.

Please take time to attend one or more public forums. These forums will be informative and provide you with sound information from which to make your decision on November 2nd.

How much will a 2.5 mil property tax increase cost me?

<i>Taxable Value</i>	<i>Amount you will pay per year</i>
\$20,000	\$50/year or \$4.16/month
\$30,000	\$75/year or \$6.25/month
\$40,000	\$100/year or \$8.33/month
\$50,000	\$125/year or \$10.41/month
\$60,000	\$150/year or \$12.50/month
\$70,000	\$175/year or \$14.58/month
\$80,000	\$200/year or \$16.66/month
\$90,000	\$225/year or \$18.75/month
\$100,000	\$250/year or \$20.83/month

Where do I find my taxable value?

Your taxable value can be found on your Tax Bill, Notice of Assessment, or you can contact the Assessor's office at 777-0940. The assessor's office can also provide you with an estimate of the amount the millage will cost you per year.
